

William was the 4th child of Jesse and Elizabeth arriving in 1852 probably in Washington County before the move to Atascosa in late 1850's. He first appears in the 1860 Census in Atascosa County with 6 siblings, his parents, and an uncle. He shows up next in 1870 after the family moved to Atascosa and everyone is still at home. Records show that in Jul 1873, he has made his way to Bell County and married Emily Spartis Guthrie. He would have been 20 and Emily almost 18. Emily had been born near Hallettsville, TX in Lavaca County in 1855 and she was one of the youngest children of William Guthrie and his last of several wives. These are the children we will be looking at in this edition.



William and Emily's children

To begin this section, I want to clarify the birth location of the children since they are reported all over the place in various Findagrave and death records. In 1880 and 1900 by which time all of the William Lawson Smith children had been born and, in both censuses, they were living in Bartlett, Bell, TX. Studying Bartlett, I found that it is on the Bell County/Williamson County line and the city hall is actually in Williamson County to the south. A couple of the boys reported Granger as their birthplace. These counties did not begin recording birth records until 1903, but my assumption is that their farm was between Bartlett and Granger which you can see on the map and all of these children were born there, not Copperas Cove and not Batesville.

Information about Pearl is pretty limited due to her short life of only 21 years. She was the first child of William and Emily and appeared in the 1880 Census in Bell County. They seem to have lived at the south edge of Bell County closer to Williamson County. Marriage records indicate that she married James W. Calhoun on 22 Oct 1891 probably in Georgetown, TX where they procured their license on the 21st. The person performing their marriage was W. H. Calhoun which I just noticed and I wonder what his relationship was to James. I have not discovered if he was related, but I find it interesting that their son who was born on 25 Apr 1896 was named William Henry and those initials

match the W. H on their marriage certificate. Sadly, Jesse died in 1896 and I can only speculate that it may have been related to William's birth although it was 6 months later.

Son William's birthplace seems to be a bit confused. Findagrave and his death certificate list it as Goforth, TX which is supposedly in Hayes County. I cannot find a place by that name, but there is a Goforth Road so maybe it's an old community that has disappeared. His WW1 Draft registration list Williamson County which is more likely while his WW2 Draft Registration say Bell County which sort of bears out the thought that they lived on the Bell/Williamson County line. My bet is that he was born in Bartlett. Bartlett is a city in Bell and Williamson counties in the U.S. state of Texas. The population was 1,633 at the 2020 census. Bartlett lies in two counties as well as two metropolitan areas. I'm a little uncertain about James Calhoun. Censuses say that he was born in Georgia to a father who was born in England per the 1910 Census. FamilySearch has him linked to a father William Henry Calhoun, but this William was born in Alabama and married in 1875 before James' birth, so I don't think that this is correct. Nonetheless, after Pearl's death, James married Luda Gann in 1898 and the 1900 Census found them in Hayes County with a new son Albert along with Pearl's son William.

In 1910, they had moved to Travis County and for some reason, young William was called Jacob and was 14. Luda and James had borne three additional children, Ruby P Calhoun, George Calhoun, Mattie Calhoun, and Viola Calhoun. They added another son Robert right after the Census and then James died in 1916. It is unclear where James died, but I think that it was probably in Travis County, because in 1918, Luda married Antonio Branaugh Brooks in Travis County. James was buried in Kyle, TX.

We will follow son William in the next generation, but he married Lena Mayes a couple of months after his father's death in 1916 and had three daughters Vida Aline Calhoun-1917, Bernice Omaray Calhoun-1919, and Hazel Roberta Calhoun – 1921. All three of Pearl's grandchildren never met either of their grandparents.

Olton is a small town in the Texas Panhandle west of Plainview. The other is of Cora with her granddaughter Jolene and her oldest daughter Velvia. This was posted on Ancestry by Sue Buerk as was the picture of Summie.

Cora was the 2nd child born to William and Emily in 1877 when they lived on the farm near Bartlett, TX. She appears there in the 1880 Census, but in Dec 1895, she married Summie Fee Bennett who was also from Bartlett. In examining

their marriage certificate, I was surprised to see that the pastor who performed their wedding was the same W. H. Calhoun who had performed her sister, Pearl's wedding in 1891. I wish I could pinpoint who he was, but I'm very much inclined to believe that he was James Calhoun's father, but I cannot find any confirming record. Following their wedding, Summie and Cora moved to nearby McClellan County which is where Temple, Waco, and Belton are. They moved after the birth of their first child, Velvia in Bartlett in 1896. It appears that they lost a child after Velvia's birth since Cora reported 2 births and one surviving. Ironically, this was the same year her sister Pearl died. Summie was working as a horse trader. I'm not exactly sure who Summie's father was. The person he is linked to is George Reynolds Bennett, but George died in 1968

and Summie was born in 1875, so that doesn't work.

After her father's disappearance in the mid-1900's, Emily moved out to Motley, TX and Summie and Cora followed along with her oldest brother Samuel. They had added a daughter, Minnie to the family in 1903 and Summie, Jr arrived in 1906. Based on the gap between Velvia's birth and Miinie's birth, it suggests that she lost a 2nd child after 1900 in addition to the one that she lost before 1900. Some records incorrectly suggest that Minnie was born in Houston, but that is highly unlikely and I contend that Minnie and Summie Jr were born in Bartlett before the move to Motley. Summie had gotten into farming out on

the High Plains. Motley is in West Texas, east of Lubbock and in 2020 only had a population of 1063, so it's no vacation spot. The County Seat is Matador and when I read that, I had chills because my least favorite teacher from Jr. High School was from Matador! Other facts that we can garner from this Census is that they had been married 14 years and Cora had lost another child as mentioned about based on the report of 5 births and 3 surviving children. They were renting their farm. In 1917, Summie registered for the WW1 Draft while living at Kirkland, TX. He was of medium height and build and had gray eyes and dark hair,

The 1920 Census finds that they had moved a little northwest to Childress, TX. Childress is right at the SE Corner of the Texas Panhandle near the Oklahoma border and is the County Seat. Before their move, daughter Mary Martha had arrived in Motley I, 1912, followed by daughter Eloyce in Motley in 1917. We also notice that daughter Velvia has left the nest and discover that she had married William Hardison about the time that her youngest sister was arriving in 1917. She then produced Cora's first grandchild Esta Beatrice in 1918. Summie and the bank owned the farm but at least he was buying and not renting. Build that equity.

For some reason Summie cannot be found in 1930. Maybe their children will give us some clues. Well look at that. Cora was living with here oldest daughter, Velvia and listed as being a widow. (Spoiler alert, Summie's not dead). Velvia is also shown to be a widow. Her husband vanished between 1920 and 1930 and no record has been found. Before he died, they had a daughter Jolene in 1923 and a son Malcom in 1927 indicating that William was around at least until 1926. They were back in Motley on a rented farm and had a young man living with them helping on the farm since the kids were too young to be of much help.

We see what Velvia was up to. Here sister Minnie married Emmett Vaughn in about 1923 and had a son Don in 1924. They lived in Olton.

Brother Summie Jr had married Olive Brown about 1926 and he and Olive had a son Billy Jack in 1927 and a daughter Peggy in 1929. They lived in Motley on a rented farm and Olive's 14-year-old brother lived with them. I haven't found daughter Martha in 1930.

Moving into the 1930's, lo and behold, Summie reappears for the 1940 Census and he and Cora are reunited in Olton TX which as I mentioned is out west of Plainview. Summie is 65 and unable to work while Cora was 62 and keeping house. The census shows that they lived in a house that they owned that was worth \$500. Summie had graduated from high school, while Cora had only gone through 8th grade. There were no street names where they lived.

In 1940, Summie at age 34 registered for the WW2 Draft. He was farming at Olton and was 6'-0" and weighed 170lbs. He was not drafted and never served.

Also in 1940, Velvia had not remarried and she was also living in Olton and was a proprietor of the PTA School Lunch Program. Her two younger children Jolene and Malcom Jr were with her and she was hosting a couple of young boarders Fred Gordon who was a school teacher and Kenneth Straw who was a pharmacist. Her oldest daughter Esta had married about 1939, but hadn't made Cora a great grandmother yet.

Daughter Minnie and her husband Emmett ran a café in Olton which they owned and Minnie worked as a waitress while their only child was ready to start high school.

Son Summie Jr. was still married to Olive and they lived in Hockley Texas just northwest of Houston. They had a new son Joe Bob in 1935. Olive's brother was still living with them and they were farming.

Martha married Herman Patrick around 1931 and they had a son K. Thomas in 1934 and they were living in Dumas TX where Herman worked at a retail furniture store.

Eloyce married William Smith about 1936 and they had a son William in 1937. They were also farming in Olton, so much of the family were in close proximity except Summie Jr.

Cora and Summie were still together and empty nesters in Olton in the 1950 Census. She was 72 and he was 75 and neither were working. They finally lived on a street with a name residing at 92 Sixth Street. That address does not exist today.

Daughter Velvia had still not remarried and was working as a clerk at a dry goods store in Childress which seemingly running a boarding house in her home as she hosted 4 young 20 something lodgers to include a couple of young men from Arkansas who were looking for oil, a young lady who was a telephone operator and another young lady who worked for a doctor. I wonder if any marriages resulted from that arrangement?

Daughter Minnie and husband Emmett were still running their café in Dumas. Living with them were their son Don along with his new wife Ella Sue and Minnie's first grandson, Donald Steve born in 1947.

At some point in the mid 1940's Summie Jr and Olive had split and Summie married Beulah Tilly who had previously been married to someone named Boyle. He had moved to Atascosa and was operating a road grader. His two oldest children Billy Jack and Peggy were no longer at home, but Joe Bob and Summie Rex were still at home and Summie and Beulah had a child together named Mickey in 1946. Billy Jack had married Verda Ross in 1944 and they had Linda Kay in 1946 and Gary Norman in 1948. Unfortunately, Billy Jack had been a bad boy and 1950 found him in prison at Huntsville. More on that in the next generation. Peggy had married Curtis Mote and they were living in Amarillo along with her mother Olive and Anna Van Meter who is described as a ward of Olive. Olive and Anna were working at a Drive-Thru, but Curtis and Peggy had no jobs listed. It appears that Peggy had married an Elmer Green in 1944 before she married Curtis.

Martha, Herman and son Kae still lived in Dumas where Herman was a radio mechanic at a radio shop. Son Kae was a teenager.

Daughter Eloyce and husband William were still farming in Olton and lived there with their 12year-old son, William Jr. Eloyce was working as a secretary at the local school.

Cora died at age 87 in Olton at age 84 from heart failure. The informant on her death certificate was her daughter Eloyce and it indicated that she was married. Summie passed away in 1972 at the age of 97. He had spent his final years in a nursing home in Littlefield which was near Olton. He took a fall in the nursing home and fractured his arm leading to his hospitalization where he passed away after 14 days. Once again Eloyce was the informant.

While her obituary claims that she was born in Copperas Cove, I still find to be an unlikely claim.

Samuel Jefferson was William and Emily's 3rd child and while he claims to have been born in Gatesville in 1879, his appearance in the 1880 Census in Bartlett tends to make me discount that. If we are to believe Cora and Sam's birth city claims, their parents would have really had to be moving

around between 1875 and 1880 from Bartlett to Copperas Cove to Gatesville and then back to Bartlett. These are the days of horse and buggy transportation and I'm not buying that they were doing all of that jumping around. Just saying....

He was still at home in 1900 in Bartlett, but Sam's life began to get a little complicated in 1903 when he married Rena Hudson Moore. Rena had first married a much older Edward Moore when she was about 17 and appears with Ed at age 42 and she at 19 in the 1900 Census in Bosque, TX which is NW of Waco. Also living with them were her younger brother and sister, Alice 15 and Joseph 8. I haven't found her parents, but this suggests that they may have died before 1900 leaving Rena and her siblings as orphans. That is speculation on my part. We then find that on 31 Mar 1903, S. J. Smith and Rena Moore were united in marriage in Belton by the Reverand O. C. Maples. On 29 Aug 1904, Rena then gives birth to Birdie Beatrice Moore fathered by her former husband Ed Moore. This is 15 months after marrying Sam. Hmm...Then in a relationship that I cannot resolve, a daughter Gertie Lawson Smith appears on 7 Feb 1904. I cannot find birth records for Gertie, but obviously she and Birdie cannot have had the same mother so either Gertie's birthday is wrong or Birdie's mother is a different Rena. Confusing. This is further confused by the fact that another child, Jesse Richardson Smith appears on FamilySearch as having born in 1906 and dying in 1907, but there are no records to support this birth and death. Then further complications arise when Rena dies in 1907 and she was buried as Rena Moore next to her first husband Ed Moore who died in 1942.

Poor little Birdie appears in the family of Angus and Alice French in 1910 at the age of 5 and listed as an orphan. She later reappears with her father Ed Moore as a 15-year-old in 1920. Ed had married Mary Young about 1908 and had a son George Moore in 1910. The only conclusion that I can draw from all of

this is that Rena and Sam's marriage did not last and that Rena left Sam shortly after their marriage and returned to live with Ed Moore and they then had Birdie before her death in 1907. This then begs the question as to who was Gertie Lawson Smith's mother. I was prepared to write her off because I could not make any connection to Sam until I read his obituary and she is named as his daughter in that. Following

Rena's death in 1907, Sam married Maggie Moon in April 1908 as seen in the Bell County Democrat 9 April 1908. Maggie had been previously married in 1899 to John Tate Moon and she and John had three children, Ollie Mae Moon – 1900, Guy Albert Moon – 1904, and Opal Pearl Moon – 1906 before divorcing around 1907. In the 1910 Census, it shows that after their marriage, Maggie and Sam had a daughter Fontie in 1909. Later records suggest that her birthday was Oct 1908, but since Sam and Maggie didn't marry until April 1908, I'm inclined to believe that 1909 is more accurate. Like his older sister, Cora. He moved to Motley County before 1910 and appears there with Maggie and her three children and their new

daughter Fontie.

In 1917, Sam registered for the WW1 Draft while living in Kirkland in Childress County. He was farming and had a medium build with blue eyes and light hair. The 1920 Census found Sam, Maggie, and the kids farming in Childress. The family had grown by 3 with the arrival of daughters Elnar in 1911, Norma Lee in 1913, and son Sam Jr. in 1917. Maggie's children were all still with them in ages ranging from 13 to 20 while Sam's kids ranged from 3 to 11. With 9 in the household, it would seem that it was getting cozy. Sam was 40 and Maggie was 36. It indicates that they were in the process of purchasing their farm and had taken out a loan.

A lot of changes happened between the 1920 and the 1930 Censuses. All of the Moon children were no longer in their house. Fontie and Elnar were gone. A new son James had been born in 1923. They

had moved to Donley County and were back to renting. Norma, Sam Jr., and James were at home. Apparently, they were living near the community of Ashtola. It was northwest of Childress and a little closer to Amarillo. I say that they lived there because sadly on 15 Jan 1929, daughter Elnar died from pneumonia and influenza. She was only 18. Let's check on the other kids.

His mystery daughter Gertie who I have not found in any census since her purported birth in Feb 1904 finally showed up in 1930 having married Jesse Nance in 1926 and producing a son R. A. Nance that same year.

The other mystery stepdaughter Birdie was reunited with her father Ed Moore in 1930 after having been an orphan in 1900 with the Frenches and then their adopted daughter in 1920. I think that I will not follow her after this.

Stepdaughter Ollie appears to have married Lloyd Morrison right after the 1920 Census and the died of pneumonia in Wichita Falls in 1922 per death certificate on FamilySearch.

I haven't found Guy Moon in 1930. Daughter Opal seems to have married William Money shortly after 1920 and had at least 4 children. I have not investigated the Moon children extensively.

Daughter Fontie married Chesley Shaw King in Pueblo Colorado in 1924 and they had a daughter Betty Jo King in 1925.

Sam lost his mother Emily in 1939 and his brother Emmett in 1941.

Sam's obituary says that he moved to Carlsbad in 1932, but try as I might, I have been unable to find him in the 1940 Census. I do not believe that this Census exists. I searched for anyone in Carlsbad in 1940 and did not get a hit. I did notice that in his brother's obituary in 1941, he was reported to be in Pampa, TX. I'll look there. No luck. I finally looked at his WW2 Draft Registration from Apr 1942 and there he is living at 312 N. Gillispie St in Pampa and working for the White Deer Land Company at 116 N. Cuyler. He was 62, claimed to have been born in Gatesville, TX. He was 5'-10"-165lbs-blue eyes, gray hair, and a ruddy complexion. He claimed that he had crippled hands. There is nothing at that address today.

Looking at the kids and starting with Gertie, she and Jesse and son R. A. Nance are back in Donley County working on the farm. To my surprise, Fontie, Chesley and Betty Shaw are in Pampa, TX. Chesley was a janitor in an office building. Norma had married Hughie Wright in 1933 and they were living in Pecos, Tx after having moved from Grand Falls, TX in 1935. Hughie was drilling oil wells. Grand Falls is a small town nearby and just south of Monahans. They did not have any children. Son Sam had married Hazel Speegle in Carlsbad in 1938, but had been living in Childress in 1935. They had a son Byron in 1939 and were living in Ector County where Sam was also drilling Oil Wells. Ector County is best known for Odessa, TX, but I don't know if he lived in Odessa. Son James must have still been at home as he doesn't show up in the 1940 Census either, but He does marry Voyzie White in Carlsbad in 1946.

Sam and Alice reappear in Carlsbad in 1950. I went through the 1940 Census, street by street in Pampa and finally found 312 N. Gillespie, but they were not at that address at the time of the 1940 Census. Sam was 70 and Alice was 66. He lost his brother William in 1956 and then he passed away in Cloudcroft in 1961 and was buried there. His obituary is as follows:

Samuel Smith Dies At 81; Services Set Samuel Jefferson Smith, a retired farmer and a resident of Carlsbad and area for the past 29 years, died Tuesday evening in a local hospital at the age of 81. Funeral services. will be at 2 p.m. Thursday from the Carpenter Funeral Home chapel with the Rev. B. R. Moffitt, pastor of the Bethel Baptist Church, officiating. Burial will be in Carlsbad Cemetery. Smith was born Dec. 16, 1879, in Gatesville, Tex.

He moved to Carlsbad in 1932, from Swearington, Tex. At time of his death, he and his wife of 53 years, Alice Maggie Lee Smith, made their, home at 1218 West Mermod. He was a member of Bethel Baptist Church. Mrs. Smith is presently hospitalized.

Survivors, besides the wife, are two sons, Sam S. and James E. Smith, both of Carlsbad; three daughters, Mrs. Gertie Nance of Carlsbad, and Mrs. Fontie Richards and Mrs. Norman Lee Wright, both of Dallas, Tex.; two sisters, Mrs. Cora Bennett of Olton, Tex., and Mrs. Lola Bennett of Clarendon, Tex.; 12 grandchildren and four great grandchildren.

Alice lived an additional 11 years and died at age 88 in 1972. Her obituary reads:

Alice Smith Services are pending with Denton Funeral Home for Alice Smith, 88, who died yesterday in a local hospital. Mrs. Smith was married in Little River, Tex., in 1908 and moved here from Paducah, Tex. She was a Carlsbad resident since 1933. Survivors include two sons, Sam S. Smith and James E. Smith, both of Carlsbad; three daughters, Mrs. Jesse Nance of Carlsbad, Mrs. Fontie Richards of Garland, Tex., and Mrs. Hughey B. Wright of Garland; one brother, Albert Grayson of Temple, Tex.; and 17 grandchildren, 35 greatgrandchildren, and five great great-grandchildren.

Her count of descendants is impressive. I'm not sure that I have tracked all of them down!

William, who apparently went by "Dock", was the 5th child of William and Emily and was probably born in Bartlett, TX. That is how he was identified in his first census in 1900.

While I haven't found marriage records, based on the date of his daughter's birth, William married Ovie Eloyce Mills about 1905 most likely in Bell County, TX. The census indicates that in 1910 they had been married 5 years which would imply that 20-year-old William married 12-year-old Eloyce. I looked to see if that 5 was transcribed incorrectly, but



it is pretty clearly written. Anyway, they waited a few years before having their first child Ethel in 1909. They lived on Rock Quarry Road, but I am unsure of the town. The big city in Bell County is Temple, but I suspect they were down near Bartlett. Ovie was the third child of Bud and Eugenia Mills who lived just up the road from Bartlett in Holland. When I looked at her in the 1900 Census, there was a 27-year-old John Smith working on their farm. I wonder what, if any relationship, he had to William.

The 1920 Census identifies their home as Holland, TX. Holland is a small town just north of Bartlett so they haven't strayed too far from home. I thought that this was an interesting bit of trivia. Holland is a city in Bell County, Texas, United States. The population was 1,075 at the 2020 census. The center of population of Texas is located in Holland. Dock and Eloyce had moved into her home town and he was working as a blacksmith. I was wondering how long blacksmithing remained a viable trade. I know my dad said that they still had a team of horses to plow their fields into the 1940's. They lived on Davie or Davis Street which I cannot find on today's maps. Son William Aubrey had arrived in 22 Jan 1912, but the 1920 Census was in January and the age was of their last birthday. In 1917, William registered for the WW1 Draft. He was living at 824 S 5th in Waco (which a CVS today) and was married to Eloyce and was 33. He was tall with a medium build and had brown eyes and dark hair. He was working as a blacksmith at a shop near his home on 5th street.

In the 1930 Census, they had moved to Waco and William had become a welder at a garage. Their address was 627 Gonlord, but that is probably a transcription error as it is not really legible. Dock was now 45 and Eloyce was 40. They were renting their home, but they had a radio. Ethel was 21 and working at a department store as a cashier and William Aubrey was 18 and driving a truck for the State Highway. This census also notes that William was 22 and Eloyce was 13 when they first married. We also note that William had not been drafted to serve during the Great War.

Shortly after the 1930 Census, William and his family moved west to Carlsbad, NM. His life was about to take a dramatic turn. In May 1932, daughter Ethel returned to Waco to marry George Frazier. The following month, son William Aubrey married Ramona Smith in Carlsbad. Both were working, William at a drugstore and Ramona for a Dr. Culpepper. In December, tragedy struck. Here is that story:

MRS. W. R. SMITH DIES OF CARBON MONOXIDE GAS Husband, Daughter-in-Law Near Death When Found TWO TO RECOVER Unvented Open-Faced Stoves Cause Death

An open-face unvented natural gas heater brought death to one Carlsbad woman this morning and two others were near death when found. Mrs. W. R. Smith. 202 North Main Street, was so near death when sha was found by Dr. M. B. Culpepper that efforts to revive her failed. Her husband and daughter-in-law, Mrs. Ramona Smith were still in a semi-conscious condition at noon- today from the effects of the gas.

Dr. Culpepper was making a professional call to the home at 9:30 o'clock this morning. the two ladies having been ill with the flu when he found the elder Mrs. Smith dying. He rushed for aid and immediately started to work to revive the three unconscious people. All three were in bed.

Ed West was called with a pulmotor but was unable to revive the woman. The physician stated that death was caused by monoxide gas poisoning resulting from the burning up of all of the oxygen in the house. He stated that he believed that the other two would recover.

The gas nearly overcame Dr. Culpepper shortly after he entered the house. Two gas stoves were burning in the house, one in a front room, and the other in a water heater in the bathroom. Neither stove was vented. Mrs. Smith is survived by her son Aubrey Smith, formerly employed by the McAdoo Drug store here, but now traveling in western New Mexico. Efforts to locate him had failed at noon. A daughter,

Mrs. Geo. Frazier, lives in Waco, Tex. The Smiths came here a few years ago from Waco, Tex. Mr. Smith is employed at the Swigart-Thomas garage. Mrs. Smith was president of the Women's Missionary society of the Baptist church and was one of the most prominent workers in the church.

William and his daughter-in-law narrowly escaped death. A couple of years later, William married Lela Hendrick who at the time would have been about 33 to William's 48 or so. In the 1930 Census she was working as a nurse in Clovis, NM at the age of 31 and had never been married. She was from Texas and the third daughter of Ed and Fannie Hendrick. She eventually ended up with 9 siblings.

I haven't found marriage records, but in 1934, Lela gave birth but lost the child and then in 1935 she gave premature birth to twins, a boy and a girl, neither of which survived. Finally, in 1937 William

Lawson Smith was born and survived. William was 52 and Lela was 38 when this birth occurred. They were renting a home at 205 ½ South Main in Carlsbad and William was still working as a welder. The census notes that William and Lela had 8th grade educations. This is surprising and makes me wonder how Lela had become a Registered Nurse prior to her marriage. I have not found a WW2 Old Man's Draft registration for William. I don't know what the age cutoff for that was, but it's not there.

I haven't located George and Ethel in 1940, but know from news stories that they were in Waco and George was in banking and involved in much public debating. Son William Aubrey and Ramona were living in Carlsbad where he worked as a chemist in the Potash industry. He and Ramona had two sons, Mallory Drennon Smith 1933 and Ronald "Ron" Aubrey Smith. Ramona must have gone home to give birth to her first child as he was born in Texas. The youngest son, William Lawson was still at home.

I have located William in the 1950 Census, but we know from his obituary that he and Lela had moved to Dallas in 1946. He would have been about 61 when that move occurred. I ran across and article from May 1950 where he and Lela sold Lots 34, 35, and 36 in Walling Heights of Carlsbad. He passed away in Dallas in 1956 and his obituary is as follows:

Funeral services for W. R. Smith, former Carlsbad resident, will be held in Dallas Saturday. Smith, who moved to Carlsbad in 1930 and then to Dallas in 1946, died Wednesday. He is survived by his widow, Mrs. Lela Smith, a son, Bill, both of Dallas, a son, W. Aubrey Smith, and a daughter, Mrs. George Frasier, both of Carlsbad. The Marrs, Mundy and Quill Funeral Home is in charge of arrangements.

William died of massive heart failure at the age of 71 at Parkland Hospital in Dallas per his death certificate. He was 4 months shy of 72 and was a retired welder. He was buried on 20 Oct 1956 at Hillcrest Memorial Park in Dallas. His wife Lela was the informant.

George and Ethel were in Snyder, TX in 1950 and George was a banking VP. They did not have children.

William Aubry and Ramona were still in Carlsbad where he was a research engineer at a potash refining plant. Ramona was referred to as Mona and their two sons Mallory and Ronald were 17 and 15.

I haven't yet found William Lawson in 1950, but maybe when I dig deeper in the next generation he will pop up. I do know that he got married in Dallas in 1956 before embarking on what appears to be a career in the Air Force.

I lose track of Lela after William's death but hopefully more information will pop up later. She appears to have died in Altus; Oklahoma in March 1975 based on her SS Death Record.

We move on to Ernest Edward Smith, the 8th child of William and Emily. His birthplace of Granger is believable since it is right by Bartlett. As with his brother William, his arrival in 1889 precluded and appearance before 1900 in a census since the 1890 Census was lost. After the disappearance of his father after the 1900 Census and the migration of most of the family to west Texas, Ernest shows up in 1910 as the

head of the remaining family which includes his mother and his younger brother and sister. If you will recall, other family members are living nearby. Ernest at 20 has inherited the care of his mother. We see again that Emily is reporting 10 births and 5 survivor which implies that there were no additional births after 1900.

In 1920, he's still looking after his mother, but they have now moved to Childress and he is working at an auto repair shop and William Hargis, a young man about the same age as Ernest and apparently a coworker is living with them. The job codes indicate that Ernest is the owner of the garage and Hargis is an employee. It also indicates that their home is on a farm. In 1917, he registered for the WW1 Draft and indicated that he was living in Kirkland, TX which is a very small town just southeast of Childress, He claimed his mother as a dependent. He was tall with a medium build and had light blue eyes and light brown hair.

In 1921, marriage records indicate that he married Isabella Allen just across the nearby Oklahoma border in Harmon County. Isabella's given name was actually Queen Isabella Allen and she was originally from Mississippi, and the daughter of Charles and Mary Adams Allen. Her father died when she was 5 and somehow, she ended up in Texas in 1920 married to Fred Snowden who was a 28-year-old man born in England who didn't know when he had immigrated. They had married about 1913 and had two sons, Charles Thomas in 1914 and Fred Robert in 1916. Both were apparently born in Memphis, Hall County TX which is adjacent to Childress County. In looking at the situation a little more closely, I'm having some doubts about the marriage date of Ernest and Isabella. I found this article from The Wichita Falls newspaper in July 1928: *HALL COUNTY MAN DROWNS BITTER LAKE MEMPHIS, Texas, July 7.- Fred Snowden, 37, drowned in Bitter Lake, 20 miles west of Memphis, TX, Friday evening about 7:30. His body was recovered about 10:30. According to reports he was in a boat on the lake fishing, and was swimming on*

his back with his feet in the boat pushing it along, when the boat capsized. In effort to right it, he took the cramps and sunk. Another man was with him, who attempted to save Snowden and was almost drowned himself.

Snowden has lived in Hall County for 35 years and is well known to all the pioneers. He lived west of Memphis a few miles. He leaves a wife and two sons. Funeral services were held Saturday afternoon at 4 o'clock from the home of his brother, Bob Snowden, six miles of Memphis.

Rev. C. E. Jameson, n, pastor of the First Methodist church, officiated. Burial was in the Memphis cemetery.

This article would seem to suggest that Fred and Isabella were still married at the time of his death in 1928. Since she and the boys appear in the 1930 Census with Earnest, they must have married after his drowning. This is contradicted however by the 1930 Census which shows that Ernest and Isabella had two daughters and a son, Ernestine 1924 born in Turkey, TX, Mary 1927 born under the name of FT in Dozier, Collingsworth County, and William Lawson born with no name on his birth certificate in Childress County Dec 1927. All of these have birth certificates with Ernest and Isabella listed as the parents. I'm not sure why they were bouncing around so much. All of these places were in the general vicinity of one another, but maybe you got to the nearest hospital when the time came. I just noticed that the youngest son named after his grandfather and he will have a cousin with the same name arrive 10 years later to his uncle William in New Mexico. I just noticed that in the 1930 Census, Ernest lived next door to his sister Lola and her family. This was his younger sister that we haven't discussed yet. Ernest was farming and was not a veteran so he missed the Great War. He said that he had first been married when he was 21 and Isabella had been married when she was 16. If this is correct, this would mean that Ernest may have been married before he married Isabella in 1921 because he was 31 when they married. I've have looked a bit in the 1910 – 1912 timeframe and there are several Ernest Smiths' getting married, but none seem to fit our Ernest.

Stepson Charles married Margaret Raker in 1938 and in 1940 he was in Memphis, TX working as a welder, a trade that he had likely learned from his stepfather, Ernest. Stepson Fred, who seems to have gone by Robert was living in Texas in 1940 and working as a farmhand.

Sometime in the 1930's Ernest and Isabella separated and she married Roy Anderson. This was most likely when he moved to Carlsbad in 1936 as mentioned in his obituary. Isabella and Roy appear in the 1940 Census in Amarillo, TX with Ernest's three children Ernestine, Mary, and William at ages 12, 13, and 16. Roy was a laborer on highway construction. The kids were all at various levels in school.

Ernest died in 1941 in Carlsbad. His obituary is as follows:

Hold Smith Rites

Today Funeral services for Ernest E. Smith, 52, were to be held at, the Baptist Church this afternoon at 4 o'clock with Rev. A. La Goodwin officiating. Smith, employed in the salt mine at the potash fields succumbed at St. Francis Hospital at 4 o'clock Monday afternoon, after an illness of five days. Surviving him are three children: son, Lawson Smith of Amarillo, two daughters, Ernestine and May Smith of Amarillo, three brothers. W. R. Smith and J. B. Smith of Carlsbad and S. J. Smith of Pampa; two sisters, Mrs. Lola Bennett of Clarendon and Mrs. Cora Bennett of Smith has been a resident of Carlsbad five years.

I note that the stepchildren are not mentioned in his obituary so perhaps they cut ties when Ernest and Isabella split. Isabella and Roy Anderson divorced in 1943 per a news article in July 1943 of The Amarillo Globe. Sometime before her death in Borger in 1953, she seems to have married John Lester Gundlach as that is her last name on her death certificate. This appears to have happened between 1943 and 1950 as John appears in the 1950 Census in Amarillo separated and unable to work. The 1940 Census indicates that he was a widowed carpenter in 1940 and I have not done any other research on him. He died in 1951 in Amarillo and Isabella is mentioned as being his former wife living in Borger. That is where she died in 1953. We will complete the discussion of the children in the next generation.

John has been a bit frustrating to research as a lot of records related to him seem to be missing. He was the 9th child of Emily and William and born in Granger in 1891 which as we have previously noted is near Bartlett between Temple and Georgetown, TX. After his appearance at age 18 in the family home in 1900 and with his widowed mother in Motley, CO. in 1910, he does not resurface in any Census that I can find until 1940. I was finally able to find his WW1 Draft registration which showed him at age 25 to be in Northfield, TX in Motley County which is near where much of the family has been found in this era. Maybe Northfield was too far off of the beaten path for the census taker to find. It's a wide spot in the road. He was married, farming, and was of medium height, stout, with brown hair and eyes. It gives his birthday as 17 Feb 1892. Apart from brother William, all of his family was in west Texas during the 1920 and 1930 period and his son Robert was born in Amarillo in April 1920 which suggests that is where he should be for the census, but he cannot be found. A search of newspapers has not yielded any results either. Let's see what we can garner from the 1940 Census.

In this census, we see that John is married to Ola King Smith who is six years younger than John and that they have a 20-year-old son Robert J. John and Ola had completed 7th grade, while Robert appears to have dropped out of high school after his junior year. John is working as a Fee Manager, at a creamery. Ola is a silver salesman (which I think is a transcription error) at a cafeteria, and Robert is a busboy at the same cafeteria. They lived at 212a E. 9th in the Potter County part of Amarillo. Amarillo is split between Potter and Randall County. They are renting and paying \$20/month. I cannot find that address today. It also says that they were in Dallas in 1935 so I will search for him in Dallas in 1930 to see if I get a hit. Interestingly, he was earning \$448, Ola was earning \$360, and Robert was earning \$270.

Let's digress a minute and explore John's wife. Records have not been found of their marriage, but based on the birth of Robert, we can surmise that they must have married about 1919 in either Childress, TX or Amarillo. In looking at Ola's background, she seems to have been the daughter of Samuel Grover King and Alice Embry King and appears with them in the 1900 Census at the age of 3 in Cherokee County

along with two older siblings, Cicero and Everett. Cherokee County is in east TX just south of Tyler. A lot of censuses for her and her family are missing, but if you follow al of the threads closely, we find that in 1901, she has a younger brother named Chesley Shaw King in 1901 who will end up marrying Fontie Smith in Colorado in 1924 and if you don't recall, Fontie was the oldest daughter of John's oldest brother Samuel Jefferson Smith so we have another incident of a brother marrying a niece. I guess that happens when siblings are born so far apart. Sam was 13 years older than his little brother John.

I found this interesting article from the 3 July 1941 Amarillo Globe: *Three Suspects Are Being Sought in Attempted Attack:* Police today still were searching lor suspects in an attempted assault ate last night upon Ola Smith a f t e r she had closed the café at 412 South Fillmore Street and was on her way home. A man described as "a tall, good- looking blond" slipped up behind the woman and tried to put his hand over her mouth, but Ola Smith struggled. As the couple struggled, a car approached and the man fled, darting into an alley of Furr Food at Tenth Avenue and Fillmore Street. Two suspects were grabbed last night but neither could be Identified. Residents in the neighborhood where the cafe operator was accosted reported a prowler last night, police said.

That address is a parking lot in downtown Amarillo today. Following this incident, John and Ola were reportedly divorced in July in Amarillo. In 1953 she appears in Las Animas, CO married to John Lewis Lingar who was a 53-year-old miner. I didn't dig deeply into John but in 1930 he was reportedly divorced and in 1940 he was widowed. He was originally from Tennessee and died in 1951. She apparently never remarried after John Lingar's death and died in Pueblo, CO in 1989.

The 1950 Census found John living in Dallas with his only son Robert and Robert's wife, Clara. Clara had been previously married and brought her 15-year-old son, Douglas Whittington to the marriage. Robert was a loan clerk at a bank. His wife was a registered nurse. John was 60 and had no job listed and reported himself as separated. I cannot find that address in Dallas and it is not very clear on the census. I will cover Robert and Clara in more detail in the next generation, but records on him are scarce also. He appears to have served in the Army in WW2 and lost a leg according to a draft registration card in 1946, but as of this writing, I haven't been able to locate any additional information about this. I cannot see where he and Clara ever had any children together.

Records and news stories after 1950 are scarce. The only record that I have found is his death certificate from 24 Jan 1980 in Dallas at Doctor's Hospital. He lived at 206 Storrs in Rockwall, TX a Dallas suburb at the time of his death and died of pneumonia and congestive heart failure. He was 88 and his son was the informant. He was reportedly a painter and indicated that he was a widower, so he may have married



again after the 1950 Census, but I haven't found any records of this. He was buried at Hillcrest Memorial Gardens in Dallas which is where his son and daughter-in-law are buried, but his grave marker is missing. His Findagrave site indicates that his nickname was "Rody" but that is the only reference that I see to that. His Social Security records indicate that his last residence was in Quinlan, TX but that his last benefit was in Dallas which conflicts with his death certificate. I was able to determine that 206 Storrs was the Rockwall Nursing Home on the shores of Lake Hubbard. Here it is after being closed for Covid.

Lola was William and Emily's 10th and final child. While she claims Gainesville as her birthplace, my earlier explanation would suggest that it was more likely Bartlett. She appears as Delores in 1900 and Lola in 1910, and then does not reappear in the Census until 1930 at which point she and Charlie Bennett are living in Cottle County in the Texas Panhandle working on a farm with their 3 sons, Lonnie Clifford Bennett 1912, William Losson Bennett 1914, and Ova Vestal Bennett 1922. The census shows that Charlie was 24 when they married in 1911 and Lola had

been 16. The boys were 17, 15, and 7 causing one to wonder if she perhaps lost a child between 1915 and 1923. Charlie registered for the WW1 Draft in 1917 at which time they lived at Northfield TX which is an area in Cottle County. He had been born in Williamson County and was married with 2 children which would have been Lonnie and Bill. From what I have pieced together, Charlie's father was George Walter Bennet and his mother was Lucy Ward Bennet. Looking deeper, it appears that his father was the brother of Summie Fee Bennet who was of course the husband of Lola's oldest surviving sister, Cora. Let's see – Lola's husband is the nephew of his brother-in-law. To my family, my sister Kathryn would have had to marry Bruce's nephew. Bruce's nephews are Nathan or one of his sister's sons.

There is not a lot of information to be found in the 1930's. The appear in 1940 in Childress living on rented farmland. The older boys have left the nest while Ova is still at home at age 18 and helping his dad on the farm. Ova seems to have quit school after the 7th grade. His father had only gone through 6th grade, while Lola was the smart one having gone to a year of high school. It looks like Charlie was making Ova do all the work since he only worked 20 hours to Ova's 40.

Charlie registered for the Old Man's WW2 Draft in 1942 at which time he was 53 and they lived on the Naylor Route outside of Donley, TX. Interestingly, Charlie "signed" with an X and someone else had written his name and witnessed his signature. He was 5'-10" and 130lbs and his contact person was his brother who apparently lived nearby.

Lonnie had married Margie Cross about 1935 and they had a daughter Starlene in 1936 and a 2nd daughter Willdene in 1939. They were still back in Cottle County and working on a farm.

William married Mary Alice Parker about 1938 and they had a son Larry Lawson in 1939. According to his records, Larry was born in Hollis, OK so William must have moved across the border for a brief period.

Charlie, Lola, and Ova appear in the 1950 Census living in Hedley, TX in Donley County, but not much information is provided apart from the fact that Charlie was 51, Lola was 55, and Ova was 28 and still at home. No jobs for anyone were listed.

Lonnie and Margie were farming in Donley and had added a late arriving son, Buddy Joe in 1947. He joined older sisters Starlene and Willdene who were 12 and 10.

William, Mary Alice, and son Larry were farming in Hale, TX. They were 31, 29, and 9 respectively although Larry's age is suspect because he had first shown up in 1940 at age 6 months in April 1940 and since the 1950 Census was taken in May through June 1950, Larry would have had to be 11.

As usual, I will cover the children's careers in more detail in the next edition, but will share that in 1956, Larry Bennett, William's son was killed in a car accident outside of Lubbock in 1956. One of the kids in the wreck in which he was killed was named Terry Allen and I thought for a moment it was the famous artist/musician from Lubbock, but it was a different person as the famous Terry Allen was a bit younger.

This completes the story of William Lawson Smith and Emily Guthrie's grandchildren.

There are several folks on Ancestry that suggest that Emily had a brother, Jeremiah Pearsall Guthrie who had a son, Charlie and then Charlie had a son Woodrow Wilson Guthrie better known as "Woody" Guthrie who wrote a few famous songs. I finally succumbed to curiosity and decided to chase this relationship. It looks like a fact that in the 1860 Census, Emily has a younger brother, Jeremiah Guthrie. For some reason over the years, she gets younger and he gets older. I cannot find the 1870 Census, but in



the 1880 Census, Jeremaiah is married to Joe Ann Sands and has three children including Charlie, while Emily is married to William Lawson. Joe Ann dies in 1881 after giving birth to Annie Maude Guthrie. Charles marries Nora Sherman in 1904. I don't know where he was in 1900, but with his mother's death and his father's remarriage he may have been off with a grandparent or uncle. Nonetheless, he does have a son Woodrow in 1912 so there you go. It looks legit. "This Land is Your Land"
