She was born in New Mexico, probably Otero County based on the 1910 Census where she is shown living with her maternal grandmother, an uncle Glen, her remarried mother Donie Matthews, and her brothers Frank and Sammie. Additionally, a cousin Thomas Hudman age 27 is with them.

1920 Census - Douglas Ward 5, Cochise, Arizona

On the 31 Oct 1923 at the age of 18, Lora married Lawrence W. Fogal in Douglas using the name Loral L. Goodsell. Prior to that she had been in El Paso based on this article from Alamogordo Daily News Thu, Apr 12, 1923 ·Page 5. Lawrence was a merchant seaman. I haven't been able to determine how long this marriage lasted, but perhaps at least until 1930 when Lawrence was picking lettuce in Washington State, while Loralie was back in Tucson and still listed as married and was listed at Loralie Fogal.

1930 Census – Tucson, AZ

Sometime after 1930, Loralie, now using the name Peggy Loralie Goodsell married Milton Mendall Manville on Christmas Eve 1932 in Lordsburg, New Mexico. Her mother, Donie who was now married to WW Lumbley attended along with her step brothers Leland and Thomas and her step sister Marshall. (These were children from Donie's 2<sup>nd</sup> marriage to WE Mathews)

The marriage of Miss **Peggy Loralie Goodsell** and Milton Mendall Manville was solemnized on Christmas eve at the home of Mrs. Eva Marshall in Lordsburg, New Mexico. Rev. M. C. Moore, pastor of the First Baptist church of Lordsburg, was the officiating clergyman. The couple motored to Lordsburg from Tucson, accompanied by the groom's mother, Mrs. P. A. Manville, where they were met by the parents of the bride, Mr. and Mrs. W. W. Lumbley, who came from Alamogordo, New Mexico, for the ceremony. Mrs. Leland E. Mathews was matron of honor and Miss Marshallene Goodsell was bridesmaid. Attending the groom were Leland E. Mathews and Thomas Goodsell.

Peggy continued working for the tax office in Tucson through the late 1930's and many articles about here traveling to visit her mother, or taking vacations appear in the newspaper if you search for Peggy Goodsell. In 1938, she nearly got washed away in floods in Tucson.

**Deputy to Rescue**

Deputy Sheriff Yeazell was called to the rescue of a woman whose home became a pond. Yeazell carried Loralie Peggy Goodsell from her home on West Delaware street a half block to dry land, wading through water up to his knees.

Trees were blown across the Casa Grande highway north of the city, blocking traffic. Telephone service in Menlo Park was disrupted. A dozen trees were uprooted at the campus of the Arizona School for the Deaf and Blind, and the wreckage of garage roofs and signboards littered the district.

The 1940 Census found her living alone in Tucson working as a stenographer for the State Tax Commission.

Changes happened in 8 July 1943, when Peggy married George Martin in Deming, New Mexico. George was the operator/owner of the local Coca Cola Bottling Company and the son of an early Deming Pioneer who had founded the first Martin Drugstore. George had been previously married, but divorced in Oct 1942. He was 20 years older than Peggy. They seemed to live happily until his death in 1967. I ran across travel documents to Hawaii and Rio de Janeiro.

**Miss Peggy Goodsell Weds George Martin In Deming, N. M.**

A wedding of interest to Tucsonians is that of the former Miss Peggy Loralie Goodsell and George Martin, manager of the local Crystal Coca-Cola bottling company, which took place on July 8 in Deming, N. M.

The ceremony was performed in the home of Judge A. W. Marshall, judge of the 9th circuit district. The bride wore a white wool summer suit and blouse trimmed in self-ric-rac, and a flower garden hat. She wore an orchid corsage.

Wedding music was played by Margaret Ann Marshall, young daughter of the judge. The couple were accompanied to Deming by Mr. and Mrs. John C. Haynes, also of Tucson.

Martin is the son of the Tucson pioneer who founded the first Martin drug store. Miss Goodsell had worked for several years in the Tucson office of the state tax commission.

Mr. and Mrs. Martin are making their home at 202 East Speedway.

## Mrs. George Martin Weds Sydney Preen

Mrs. George Martin was married to Sydney David Preen June 4 in Santa Ana, Calif. The couple will divide their time between Tucson and La Jolla.

Mr. and Mrs. Thomas Goodsell of Garden Grove, Calif., Mr. Preen's brother-in-law and sister, and Margaret Bernham of Tucson.

Mrs. Preen is the widow of George Martin, pioneer Tucson businessman. She belongs to the University of Arizona President's Club, the UA Foundation, Tucson Woman's Club, Old Pueblo Club, Elk's Auxiliary, Opera Guild of Southern Arizona and The Tucson Symphony Women's Assn.

Her husband, a frequent winter visitor here, is the stepfather of John Wayne. He belongs to the American Society of Civil Engineers and is president of the Water Pollution Control Assn. of California.

Following George's death, Peggy at age 66 married Sydney David Preen. Sydney was 71 and had an interesting background. He was originally from New Jersey and went off to fight in WW1. In April 1930 in Yuma, Arizona he married Mary Brown Morrison. They were both from Long Beach California and incidentally, Mary had previously been married to Clyde Morrison and had a couple of sons, Marion Morrison and Robert Morrison. At the time of their marriage, her oldest son, Marion working under his stage name John Wayne got his first starring role in "The Big Trail" and went on to become fairly well known. In 1946, they hosted his 2<sup>nd</sup> wedding at their home. Sydney rose to head up the Long Beach Sewer Department. In 1970, Mary died so he and Peggy got married.

Sydney died in 1982, and Peggy in 1986.
