LINEAGE LIST NOTATION

This document is written in “*Register* format,” a format popular with scholarly genealogists named for the New England Historic Genealogical Society (NEHGS) and its learned journal the *NEGHS Register*. To facilitate stepping “backward” through the genealogy, I utilize one small addition to standard (actually “modified”) *Register* format. A leading subscript to a person in a lineage list is the person number for that individual in this work. For example, Caleb Smith⁶ Riggs (₇₀Joseph⁵, Joseph⁴, Edward³, Edward², Edward¹) was son of person 70, Joseph⁵ Riggs (₃₇Joseph⁴, Edward³, Edward², Edward¹), who in turn was son of person 37, Joseph⁴ Riggs, and so forth. This technique may be applied to any person in a lineage list. However, to reduce visual clutter, I will use it here for at most one person per lineage list, usually the first.

A superscript asterisk (*) indicates the first person in a lineage list who is not genetically related to the next older person in the list. For example, Skylor Nathan^{13*} Knoll (*Martha Jane*¹², *Edward Clark*¹¹, *Theodore Dalzel A.*¹⁰, *Edward*⁹, *Elias*⁸, *Elias*⁷, *Preserve*⁶, *Zebulon*⁵, *?Joseph*⁴, *Edward*³, *Edward*², *Edward*¹) was an adopted son of Martha Jane¹² Riggs. Note also the question mark (?) in this lineage list, indicating that the father-son relationship of Joseph⁴ and Zebulon⁵ has not been proved.

It is traditional in American genealogy to label the immigrant’s generation as no. 1. The generation preceding his is A, preceding A is B, and so forth.

METHODOLOGY AND STYLE NOTES

Un sourced material. Some claims without accompanying sources are important to preserve, as hints to future researchers or simply to indicate that I am aware of commonly claimed dates, names, or places, but am not certain of them. I enter these in footnotes and not in the main text. I do not always explicitly flag these claims as unsourced, but they should be understood as such by their presence in the footnotes only. This type of information often comes from compiled, but unfortunately unsourced, genealogies that have the appearance, to me at least, of being well researched and based on solid evidence. The footnote hint might inspire a future researcher to find the elusive evidence, whereas I had not done so by the time this book went to press.

Census litany. Rather than trying to be creative on each of dozens of census readings, I have chosen to state them with a common “litany.” To make census litanies easy to spot, I usually introduce each one with the year. For example, a reading from the U.S. census for 1900 will begin “In 1900”

Online sources. I have made much use of online sources, usually secondary, such as the listing of gravestones in a particular cemetery. The problem with this practice is the supposed ephemeral nature of the web. Many online sources may simply disappear from the web over time, or change addresses at least. I have therefore made a copy of every webpage used in this work and archived it for future reference. Very notable exceptions are the many databases available from major servers, such as <Ancestry.com>, which I assume, with some trepidation, will be permanently available by some means. The URL for a website is identified by enclosing < > brackets. When a URL needs to wrap at the end of a line for good visual appearance, I have inserted a hyphen in an appropriate location. This line-breaking hyphen should be omitted, of course, when the URL is used as an internet address.

Abbreviations. I use abbreviations. With one exception, I always abbreviate state names and month names. The exception: I do not abbreviate

state names in the main text that stand alone. However, state names in footnotes are always abbreviated, even in the titles of books.

I do not abbreviate anything in a quotation. An abbreviation in a quotation is present in the original.

I use succinct forms for the sources in footnotes. The bibliography should be consulted for full expansion of a source reference. See the abbreviations section of the front matter for the full list of abbreviations used in the census references. In all cases, the census was read from <Ancestry.com>, and the roll numbers correspond to the microfilm series used by that organization.

Verb tenses. Past tense is normally used, but a record is described in the present—e.g., Joe Gopnik was born in 1836, but a death certificate for Joe Gopnik states that he was born in 1836.

PREFACE

This is a living document, which is just a way of saying that it is incomplete. It can be added to or corrected at any time. I expect family members to suggest changes and additions. Items in red are facts lacking proof or otherwise indicate questionable information. I hope that together we can “take the red out.”

2. **JAMES² EDGAR** (¹[immigrant]¹) was born about 1810, Albany Co., N.Y., probably he who died 29 Nov. 1885, and was buried 1 Dec. 1885 in Cypress Hills Cem., Brooklyn, Kings Co., N.Y. (where his son Frederick was buried).^[2] He married 1833 **CLEMENTINE⁶ UNDERHILL** (⁵Amos⁵, *Abraham*⁴, *Abraham*³, *Nathaniel*², *John*¹), who was born 31 Mar. 1813, New York Co., N.Y.,^[3] daughter of Amos and Parmelia (Avery) Underhill,^[4] and who died 8 or 12 Dec. 1863, Kings Co., N.Y.^[5] See appendix A for Clementine⁶ Underhill's descent from Capt. John¹ Underhill.

On 3 Mar. 1832 "Clementina" Underhill was listed as a member of the Methodist Episcopal Church of New York, N.Y.^[6] This might have something to do with her being disowned by the Quaker meeting in Apr. or

In 1850 James Edgar, 40, a grocer born in New York, resided in New York, New York Co., N.Y., with Clementine, 37, born in New York, and with Samuel, 17, a clerk, Robert, 15, a clerk, James “W.,” 10, Frederick, 8, “Adelaid,” 5, all born in New York, and with Mary Thorne, 63, and Mary Wordsdale, 52, both born in New York.^[7]

In 1855 James Edgar, 44, a grocer born in Albany Co., N.Y., resided in Brooklyn, Kings Co., N.Y., with his wife, “Clementina,” 42, born in New York Co., N.Y., and with his sons, Samuel, 21, a clerk, Robert H., 20, James “H.,” 14, and Frederick E., 12, and his daughter, “Adalaide,” 8, all born in New York Co., N.Y., and with one servant, Catharine Fox, 18, born in Ireland. All of them had resided in Brooklyn for two years [implies they moved to Brooklyn about 1853].^[8]

In 1860 James “Edgert,” 49, a grocer born in New York with \$500 real and \$2,000 personal estates, resided in Brooklyn, Kings Co., N.Y., with Clementine, 47, born in New York, and with Robert, 24, a clerk, James, 20, a clerk, “Fred^k,” 18, a clerk, “Adalaid,” 14, all born in New York, and with one servant, “Cath Fix,” 23, born in Ireland.^[9]

In 1865 James Edgar, 55, widower, a marketman born in Albany Co., N.Y., resided in Brooklyn, Kings Co., N.Y., in the household of his son, James “H.” [possibly N.] Edgar, 25, a bookkeeper born in New York Co., N.Y., with his wife, Samantha V., 21, born in Kings Co., N.Y., and with his [James Sr.’s] daughter, Adelaide M. Edgar, 19, single, born in New York Co., N.Y.^[10]

In 1860 Samuel Edgar, 26, a flour dealer born in New York with \$600 personal estate, resided in Brooklyn, Kings Co., N.Y., with Eliza, 26, born in New York, and with Howard, 3, and George, 1, both born in New York.^[13]

In June 1863, Samuel Edgar, 30, a flour dealer, married, born in New York, registered for the Civil War draft in Brooklyn, Kings Co., N.Y.^[14]

In 1880 Samuel Edgar, 45, a flour dealer born in New York of New York natives, resided in Brooklyn, Kings Co., N.Y., with his wife, Jennie, 40, born in New York of Ireland natives, and with his sons, Frederick H., 22, a store clerk, George H. B., 21, a railroad clerk, and Arthur W., 18, a store clerk, daughter, Grace M. E., 10, son, Samuel, 4, and daughter, Jennie, 2, all born in New York, and two Black servants.^[15]

On 15 Apr. 1896, Eliza J. Edgar, the widow of Samuel Edgar, late of Brooklyn, petitioned the Surrogate’s court of Kings Co., N.Y., to apply for letters of administration on his estate, which was intestate. She lists the next of kin as: “Eliza J Edgar, Widow | Frederick Howard Edgar son | George H. B. Edgar son | Arthur W. Edgar son | Grace Edgar Hunnewell Daughter

In 1865 Robert Edgar, 30, a clerk born in New York Co., N.Y., now married and with three children, resided in Brooklyn, Kings Co., N.Y., with George Kirk, 50, born in Scotland, now married and with no children, and his [George’s] wife, Catherine Kirk, 40, born in Scotland, and with children, “Harriett” Kirk [*sic*], 5, William Edgar, 4, and “Clementia”

Edgar, 1 9/12, all children born in Kings Co., N.Y. Surely Harriett should be Harriett Edgar.^[21]

In 1870 Robert H. Edgar, 26, a store clerk born in New York, resided in Brooklyn, Kings Co., N.Y., with Mary E., 28, born in New York, and with Harriet H., 11, William, 9, “Clemitina,” 7, and Frederick, 4, all born in New York.^[22]

In 1875 “Rbt.” H. Edgar, 41, a watchman born in New York Co., N.Y., resided in Brooklyn, Kings Co., N.Y., with his wife, Mary E., 33, born in New York Co., and with daughter, “Hattie,” 15, son, “W^m,” 13, and daughter, Clementine, 10, all three born in Kings Co., N.Y.^[23]

In 1880 Robert H. Edgar, 44, a grocery clerk born in New York of a father born in New York and a mother in Pennsylvania, resided in Brooklyn, Kings Co., N.Y., with his wife, Mary E., 38, born in New York of Ireland natives, and with his son, William E., 18, a collector, daughter, “Clementina,” 15, and son, Theodore, 4, all born in New York.^[24]

On 8 Jan. 1886 Mary E. Edgar applied from New York for a widow’s pension for the Civil War service of Robert H. Edgar, Company G, 139 New York Infantry. It appears not to have been granted.^[25]

In 1888 Mary E. Edgar, widow of Robert H. Edgar, and William E. Edgar, machinist, resided in Brooklyn, Kings Co., N.Y.^[26]

APPENDIX A. UNDERHILL NOTES

This is an abbreviated Underhill genealogy for Clementine⁶ Underhill, who married James² Edgar. Capt. John¹ Underhill came to New England in the 1600s in the Winthrop Fleet.^[92] His genealogy is well documented in the *Underhill Genealogy* (1932) by Josephine C.
